RELEASE OF LIABILITY AND TERMS OF RENTAL ITEMS

1. Payment and deposit on all items must be made one month before trip departure.
2. A deposit is required on all rental items. The deposit will be refunded to you in a timely manner for all items that are returned to us in good condition. Part of your deposit may not be refunded for damaged items beyond reasonable wear and tear. We will also assess a “cleaning-fee” if the items are returned dirty, wet, or improperly packed. The deposit will not be refunded for any items not returned to us.
3. All items are to be returned directly to the trip leader (or a designated staff member) at base camp or in Kashgar by or before completion of the trip.
4. I understand that there are INHERENT AND OTHER RISKS involved in the activities for which this equipment is to be used. I freely and voluntarily assume those risks, including the risk of serious injury or death.
5. To the fullest extent allowed by law, I agree to RELEASE, HOLD HARMLESS AND INDEMNIFY BlueSheep Inc., the manufacturers and distributors of this equipment, and their owners, agents and employees from any and all liability for injuries or damages to the user of this equipment or to any other person or property resulting from the use of this equipment. I myself, my heirs and assigns agree NOT TO SUE nor make a claim against BlueSheep Inc. nor the manufacturers of this equipment for injuries or damages relating to the use of this equipment.
6. I understand that BlueSheep Inc. has done everything in its power to ensure that the correct equipment has been supplied and is in good working order.
